During development process for this collection, we've come across a few points we'd like you help us clarify

- Regarding jacron patch as shown in image below, could you please let us know if your requirement is for leather patch or one-of-a-kind material that has a leather-like appearance?
- BL 5/22: Please make the jacron patch in leather
- Truc 5/26: After discussing with supplier, we would like to inform you about two options to choose.
   Please let me know if you consider using the PU leather patch. I believe it would be a suitable option to proceed with, especially for a small order quantity.

Left image: leather patch - the price is approximately \$0.72

Right image: PU leather patch - it has a similar quality and appearance to real leather, but costs about half the price, approximately \$0.39.

BL 5/28: Lets do genuine leather please, I will send you the exact one that we use for reference.

- For THERMAL STRIPE ZIP UP HOODIE, we noticed a typo write "CALLOUT DOUBLE LAYER THERMAL FABRIC". Could you please share with us the purpose of double layer? If you want both outer and inner of garment to be right side of fabric, it will require a different construction than simply making hoodie look thicker with only right surface in the outside, like a regular hoodie.
- BL 5/22: We would like to use the same thermal fabric as the FW24 COLLAGE THERAMAL LS TEE. Since the fabric is too thin to use as one layer, we would need to double layer it in the same fabric to make the hoodie. Please let me know if that makes sense.
- Truc 26/5: Yes, it's able to make the hoodie that way. However, when double layer the striped fabric, the inner striped pattern may become visible from the outside when worn. Therefore, we think you might be interested in using striped fabric (like TP file) for the outer layer, and layering it with a solid fabric on the inside. Please let me know if our suggestion is acceptable for you.
- BL 5/28: We are ok to move forward with a solid fabric inside, please ensure that the interior fabric matches the base fabric color. For example, for the cream colorway, the interior color should be the same solid cream color. Let me know if that makes sense.
- About PLAID ELASTIC HAT, it shows that elastic sweatband would be used as image below. Kindly confirm if you refer to have text on as shown in this one or not.
- BL 5/22: The reference photo is meant for quality, not for text. You can also reference the SS24 WINSLOW HAT for the sweatband reference if needed.
- Truc 26/5: Well noted with thanks!
