Noted the MOQ /MCQ. I will discuss with mgmt but in the meantime, pls start on the sampling. Kindly advise the cost of the sample yardage.



Just got information from supplier, MOQ = MCQ is 700m/color and approximately 1500units/color. If colors can be repeated, we can keep the fabric in stock and continue producing until it is used up
